On 21 Feb 1575 the queen granted to Thomas, earl of Ormond 1 mes., 2 cottages & 7a. in Rathehulke, co. Dublin, at rent. The earl sold them to Walter Golding of Grange of Portmernoke, who granted them, along with all his lands etc. in Kinsaly & Sanctrife & other lands, to Thomas Wading of Waterford, gent., Walter Segre of Dublin, merchant, Richard Golding of Rathehulke, his bro., to the use of himself & Elizabeth his wife, for life, & then to that of Richard Segre of Killeglan. gent., until the latter or his executors etc. should have raised £300 for Catherine, grantor's only dau. & heiress apparent & whichever of Richard's sons should have married her, in tail male, remainder to Richard Segre, his heirs etc., & after the raising of the said £300., to the use of Walter Golding, in t.m., remainder to the uses of Walter's will. Walter then declared his will, that feoffees should be seised to the use of his bro., Richard, in tail male, with divers remainders.

On 10 Dec 1592 Thomas Wading & Walter Segre, the suriving feoffees, granted the premises to Thomas Hacket of Sutton & Thomas Cadell of Swords. Richard Cadell of Nall, George Cadell of Cadelston, Robert Cadel of Morton & Stephen Fitz Williams of Ioliston, co. Dublin, gent., then recovered them against Thomas Hacket, Thomas Cadell having died, to the use of Andrew Golding of Rathehulke, s. of Richard, in tail male, with remainders as in a deed of 8 Sept 1952. Andrew is still living. The lands in Kinsalie are held of the dean etc. of Holy Trinity, Dublin, by fealty & rent, & those in Sanctrife of Nicholas Eustace of Confie as of his purparty of the manor of Sanctrife.
