Some Limerick Wills. Transcribed by Noel Murphy.

1. Abstract of the will of Malochey Ryan of the City of Limerick. Written 11 August 1729.

I bequeath to my wife Catherine Ryan £500. To my son Richard £500 etc. To sons Malochy and William £400 each. To daughters Catherine and Margaret £400 each, provided my worldly substance answers so much and if not to be deducted in proportion etc.

If any of my children should happen to die, fortune of same to be divided amongst rest etc, etc.

I order farm at Grange to be sett to highest bidder except 40 acres to be reserved for use and pleasure of wife and children and the income of Grange together with all my other farms to be equally distributed for support etc of said wife and children. But should wife marry she shall have no right to said income etc except the £500 before bequeathed to her etc. etc.

I doe nominate etc my dearly beloved wife Catherine Ryan, my beloved Brother [in-law] Richard Harrold and my kinsman Timothy Ryan, both of the City of Limerick, Gents. Exors. of this etc.

Note: - William Ryan above is the same William Ryan who left the next Will.

2. Abstract of Prerogative Will of William Ryan of Tipperary, Clare and Limerick. Written 17 June 1763. Admon. 20 March 1764

William Ryan late of the City of Limerick, Merchant, appoints Dr. John Martin sole exor. Bequeaths £50 to Mary Hanneer, £10 to the clergy, £10 to the poor, the rest of my fortune I leave to my brother [in-law]Richard Roche and his wife, my sister, requesting he will give something to my poor relations.

Will signed in the presence of John Martin M. D. John McNight Chir. (Surgeon) And Michael Hickey M. D.

Admon granted to Richard and Catherine Roche, 30 March 1764.

Note: - Catherine Ryan nee Harrold, widow, natural and lawful mother and next-of-kin of the above William Ryan together with Catherine, Ellinor, Francis and Margaret The natural and lawful nephew and nieces disputed unsuccessfully the Will of the deceased.

3. Abstract of the Will of James Ryan of the City of Limerick. Written 4 April 1748. Admon. 28 July 1748.

I will my body to be buried in St. Munchin's Church yard near to the body of my late wife, Mary Brown.

I bequeath unto Ruthy Brush, 4 table spoons etc, 4 gold rings, 1 plated Thankard which are now in the hands of my friend Mr. George Mason and I order them to be given etc unto the hands of Mr. Richard Harrold of this city for the use of Ruthy Brush, to be kept for her until she comes to the age of 21 or shall intermarry and in case she should dye I order that the said plate shall revert to the use of my three children by said Mary Brown to wit, Molly, Nelly and Johanna to be equally distributed between them and I also order the legacy grants to Ruthy Brush shall be subject to her intermarriage with the consent of the Revd. John Smyth and said Mr. Harrold before she shall arrive at 21 years, otherwise not.

I bequeath to my wife Priscilla Ryan nee Pretty, exclusive of the marriage articles between us, my lease and interest in my dwelling house etc. etc.

I leave etc to my three children Molly, Nelly and Johanna Ryan my boat and all its furniture etc as also my interest in the West of Co. Clare, City of Limerick by leases to be equally devided between them etc.

Exor, Rd. Harrold and Danl. McInerheny Witnesses, George Mason, Maurice Nugent and Edmond Menelly.

4 Abstract of the Will of William Ryan of Annagh in Co. Limerick (This William Ryan died in 1634).

Bequeaths his body to be buried in the Abbey of Owney.

I bequeath to niece Mgt. Walsh, four bulling cows etc.

I bequeath to my daughter Shiela, twelve cows etc.

I doe bequeath unto my son-in-law Edmund Barnett all the rents due from him out of the lands which he holds from me together with twenty three pounds which I lent him and for which I have his bill.

I bequeath to my grandson John Ryan six calf cowes and six cows bulling age next summer, eight mares etc and the rick of oates standing at Gortowly and the benefit of the lease I hold of the Townlands of Killmacrgie.

I do bequeath unto my son and heir Connor Ryan the several towns, villages and hamlets and lands of Rathfarnan and Toburgcariff in all three plowlands in the foresaid County of Limerick and the fourth part of the great tithes of the parish of the Abbey of Owney, Calverkinlish, Caherelly, Rathgodan and Ballirollie. I bequeath unto him all my corn in ground and above ground at Portannecastle etc etc.

And my will is that all my goods and chattels shall be devided into three parts except 100 sheep of English breed which I bequeath unto my wife Amy Ryan. I bequeath one third part to my said wife and one third part to Connor my son and one third part to my daughter, the youngest.

5. Abstract of the Will of William Ryan of Limerick, Wheelright.[sic] Written 27 Nov. 1762.

I bequeath my body to be buried in St Mary's Church yard in City of Limerick.

I.leave etc unto my brother Richard Ryan's three sons, Viz: - Daniel, Richard and Henry Ryan and their heirs, my nephews, the two front houses and back houses in Castle Street and the house wherein I the said William Ryan now live in.

I leave to Daniel Ryan and his heirs etc etc. Nevertheless receiving out of the rents, profits etc. (Makes no sence)

To my wife Margaret Ryan orse (otherwise) Molony £2-10-0 yearly etc etc. together with the flaxshop and liberty of trafficking as usual in the Manufactureway etc and after her decease to go to said Daniel, Richard and Henry to be equally devided.

I also bequeath to my sister Bridget Barrett orse Ryan my plate Buckles.

Failing issue to above nephews I leave estate to my brother John's children i.e. John, James and William now in Cork City, their heirs etc.

6. Abstract of the Will of William Ryan, City of Limerick, Innholder. Written 4 Dec. 1800 Admon 24 Dec 1800

Whereas I am seised and possessed of divers Estates and properties, both freehold and chattels and also possessed of personal property to a consideral amount Viz: - amongst others, of land in Doonedayle (Dooradoyle) adjoining the lands of Rossbrien, [and] the lands of Rathbane. Also a piece or plot of ground called the Pump Yard adjoining the concerns one held by Thomas Owens, Innholder, a house and concern in the Square now held by me and also a large concern and House at the back of the Square commonly known by the name of Taylors Inn. All of said houses etc are situated in the County of the City of Limerick.

I give, devise, etc all my estate and interests therein unto John Bouchier of the City of Limerick etc upon trust for the payment of all just debts etc and to suffer and permit my brother John Ryan during the term of his natural life to receive and take therefrom yearly, etc one annuity rent of £15 and also to permit my wife Ann Ryan to take out of the rent, issues and profits of the said lands and premises in addition to and over the sum of £32 yearly already secured to her by her late husband Thomas Taylor the sum of £20 yearly etc etc.

I bequeath £10 to Edward Taylor and to Ann Taylor for mourning and the residue of all my possessions to my dear friend and kinsman Thomas Francis Wilkinson of the City of Limerick etc.

Leaves all he possesses to his sister Ellen Cragh and makes her husband William Cragh sole Exor. Except to Maria Bartley daughter of Edward Bartley £50 and all his utensils to his brother John Ryan.

8. Abstract of the Will of Daniel Ryan fitzWilliam. Written 23 Jan. 1629. Admon. 10 May 1630.

I bequeath to my well beloved wife Ellenor Ryan orse Cody all my goods and chattels etc and the leases of the lands of Laygoil with appurtenses during her life and after her decease to the last of my children and youngest son James Ryan etc etc. Failing issue to be given to Henry Ryan my second son and the issue of his body lawfully begotten and for want of such issue to my son Darby and his issue.

Adebt of £45 due to me of Mr. Edward Fitzgerald, merchant of Waterford, £240 due to me of Mr. John Ryan of Waterford, Merchant. My will is if I dye in Dublin no more than £15 - £20 costs of funeral and I am to be buried at night. Cn. Pierce Boyton shall oversee funeral. I appoint my father-in-law Major George Mathew of Thurles, Mr Hugh Kennedy of Poulsnorman and Howard Egan of Ann[o---le, Excrs. Should any of these die before such distribution is made I nominate my kinsman Mr. Justin McCarthy of Spring House and Redmond Purcel of Fethard, my Excrs.
