Items

Discharged from Custody

The programme of the Theatre Royal is to have a good housekeeping this week, and is being highly appreciated. It is varied and interesting, and should not be missed by anyone who wishes to enjoy an entertainment of all-round excellence.

Increased Fuel Prices

The price of coke in the city, as will be seen from an announcement in yesterday's advertisement, has been increased by the Gas Committee to 80s per ton at the works, and that of horses to 25s per ton. Is 6d per ton extra being charged in both cases for delivery within the city.

Limerick Officer's Gallantry

The Cabinet met yesterday for the first time since the Prime Minister's return to London, and it is understood, discussed his report of his visit to Ireland and the conclusions at which he has arrived as to the future government of the country. As to the nature and result of the proceedings no definite information has leaked out, but the statement reached the Lobby of the House later on that while the ground had been explored in preliminary conversations no actual negotiations had yet been begun. The most striking and significant circumstance in connection with the whole matter is the completely altered attitude of the Tory press. Practically every Unionist journal of any repute in Great Britain is to-day vigorously arguing a settlement of the Irish question on the lines of handing over to the people of Ireland themselves the management of their own affairs. In fact "Ulster"—in the Garonne sense—appears to be the one and only remaining obstacle to the immediate bringing of Home Rule into operation. Referring to the remarkable change of attitude on the part of the English Unionists, the London correspondent of the Freeman's Journal says—"Their change of heart, as far as I can see, has been brought about by a desire from the navy, was charged by Captain Hennessy, with having drunk heavily, and he was remanded until the Petty Sessions on Friday. John Butler, charged with drunkenness, was discharged on giving an undertaking to leave the city, and that he would not offend again.

THE POTATO CONTRACT

Statement by Acting Master

At the weekly meeting of the Kilrush Board of Guardians on Saturday, Mr Thomas Ryan, U.C., presided. The other Guardians present were—Messrs William Carmody, J. P. Michael Moloney, Thomas Burke, Patrick O'Brien, T. W. Kelly, Cornelius Killian, and Joseph Brown, J.P.

Messrs T. Kelly, Clerk of the Union; P. J. Kelly, Assistant du; Sionon Clancy, Master of the Workhouse, and Patrick Mongovan, Clerk of Works, were present.

A resolution of the Athlone Board of Guardians in favour of a yearly instead of half-yearly audit of accounts was carried read.

Mr Moloney reported for the supply of new milk to the institution from Thomas Prendergast, Prender-

gast, 16 gallons daily, at 1d. per gallon.

Patrick O'Brien, 13½ gallons daily, at 1d. per gallon; James Brown, same quantity and same price.

Chairman.—How many gallons do you require daily?

The Master (Mr. Martin)—About 80, and 20 extra on Wednesdays and Fridays.

Chairman.—You have only tenders for forty gallons.

Mr O'Gorman.—You had no difficulty in getting the milk for the fortnight.

Master.—No, some of the old contractors continued at last year's price, and whatever I wanted after I got a creamery.

Mr Moloney.—The contractors who tendered, I propose that you reject them.

Mr Carroll added before the motion was adopted he desired to point out that four or five weeks ago they were prepared to accept tenders at 1d. a gallon. Would they take that figure now?

Mr Prendergast said he would not take less than that mentioned, but Messrs Brown and O'Brien assented to the offer.

THE POTATO CONTRACT.

The case of the potato contract, in which it was alleged that the potatoes supplied to the contractor by a man at the market were weighed at the market house scale, and weighed ten stones more at the workhouse than at the public scales, again came up for discussion.

The Acting Master (Mr Patrick Mongovan) stated that on that occasion he weighed other quantities of potatoes supplied by the contractor, and the scales of some of those came to the porter to be entered on the books, &c., one in one of these deliveries left in the hall of the contractor was weighed on the same day. He then produced his book for the week of that day, showing that the man who had been adopted for that week, instead of the whole thing was, in fact, weighed at the market house scale, and paid for 40 stones more than he received for 40 stones.

Mr Mongovan made an order for the attachment of £150, to be paid pro rata, on receipt of the pension.
