Report From Inspectress

T P Gill, Secretary Department of Agriculture and Technical Instruction, enclosing a report of the Inspectress, Miss Anderson, who acted as adjudicator of work in the Home Industries Olasses at the Show.

The report stated :- The exhibits were numerous and varied in character. Besides the usual groups of plain needla-work, elementary dressmaking, blouse making, embroidery lace and crochet, there were classes for down carpets, renovation and remodelling of worn clothing for children's use and dressed doll competition. Drawing thread work and handanger embroidery-Work in this group attained to a high level. It was generally sound, artistic in style, and practical in character. Plain made pillow lace, deserve special commenda-tion. In the junior competitions some very oreditable work by school children was noted,

especially in the section for overalls and pinafores. Remedelled garments, men's worn. clothing cut down and remade for boys' use-It was satisfictory to notice the keen competition in this thrifty and eminently practical class. The garments were generally well cut, strongly mode, and neatly lined throughout. Limerick Lace-With two exceptions a lace collar and blouse work in this group was disappointing both in dealgn and execation. The selection of good modcon patters or reproductions of fine examples of the early 19th century is strongly recommended. It is regrettable when time and material are wasted upon bold and inappropriate designs. Down Coverlets-There were good examples of bed drapery, being light in weight and well made. This class of coverlet appears very preferable to the usual heavy, counterpane formed of silk and cloth-patch-

The Judges made the following reports :--Butter-The quality was of a very high order. The flavour and texture in nearly all cases were excellent, and it was really difficult to make the award so close was the merit of the exbibits. Agricultural Produce-The exhibits were of much more than average quality, and in most classes a very high degree of excellence was attained. In the various classes for potatoes, besides the high quality of the exhibits, great care and skill had evidently been bestowed on the selection of samples true to a definite type, while uniformity of size and shape was a marked feature. In the root and green crops many of the exhibits were magnificent, especially so when the climatic conditions prevailing during part of the sesson are taken into consideration. In the grain crops the quality of the production was not up to last year's high standard, but the weather during harvesting operations has been largely responsible for this. The agricultural produce section of this year's Show has been a pronounced success ; the exhibits have distinctly improved during the past few years in uniformity, quality and trueness to selected type.



The Sergeant said in July, 1914, the children of Martin Hanly were sent to industrial schools, and an order was made against the father, who paid it up to the time of his death ; he made no will and his brother, James Hanly, took up the guardianship, and took out administration o the 7th September last ; it was necessary to take out a new summons; there was a farm of 23 scress of land which had been grazed by the 11 months system; he was instructed to ask for a substantial sum for each child, say 2s each or 14s a week; the land brought in £40 a year. 
