The hymn "The King of God My Shepherd Is" was sung by the surprised choir of the Cathedral, and also the 90th psalm, "Lord, Thou hast been our refuge from one

generation to another."

The Dean said—It is now my duty to say a few words about our dear departed brother. There are three relations in life which we shall bear. These are our relation to our home, our relation to the public, and our relation to God. Well now we think first of all of the home relation, and we think of how our brother who is gone from us was so much beloved in his home. It is not for us to draw aside rudely the veil that always must exist in home life, but I think you and I, and all of us, must feel the deepest and most entire sympathy with those persons who belong to that home, and who have been so beloved of him who has been taken from us. Especially I ask you to give your greatest sympathy to her who has been for so many years the fruitful helpmate to this our friend. The love which passes all human understanding existed between them, and anybody who feels the sacredness of home life must feel I think, the deepest and truest sympathy for this our beloved sister, and not only that but the other relations in the home life, the relation of father to children. Now, I had the happiness of knowing that that love was deeply observed and no family could be more united. The father with his family, the man with his brothers, and the friend with his friends. We cannot say anything better, I think, than that as regards the sacredness of home life. But then there is the other portion of our friend's life, that was his public life, and that concerns us all in this old city of ours. We know very well that in every public concern that the late Sir Thomas Cleeeve was most anxious to do his duty in that place which God had put him. There was nothing in which he did not interest himself where the welfare and benefit of the community was concerned. He did employ, as we all know, a great number of persons in the industry which he built up during his life. What does that mean? It means this that the man had intelligence, that he had industry, that he had courage, that he was not going to fail, and he did not fail. And now my friends some of you no doubt have been employed by this good and excellent man who has passed from us and you will say with me that he was just and firm in his work as a public man, and that in everything which concerned your interest you felt that you had been with one who showed himself to be your friend in every particular of life. Then there is this other further relation, and it is the most sacred of all—namely, the relation which a man has with his God. Now, many and many a time have I seen Sir Thomas Cleeeve sitting in his seat there, and many a time going with his dear wife to partake of the Sacrament of the Lord's Supper, hand in hand. That is to say, giving themselves to the thoughts in their relations with the great Father of Spirits. It is the best and most solemn duty that can come to our minds, of all life so consecrated to this religious service.
