**DEATH OF MRS RIORDAN.**

Mr McInerney rose to move the adjournment of the Board, and pointed out that it was usual to do so when a member of the board or his wife died. He had very great pleasure in proposing that the board do now adjourn as a mark of respect to their deputy vice-chairman, Alderman Riordan, and in doing so was sure that the board would unanimously agree with him. He also proposed that a vote of condolence be sent to the family of Mr Riordan.

Mr Bourke seconded the resolution.  
The Chairman (Dr O'Shaughnessy) said he rose to tell the Board that he acceded to the suggestion as chairman of the Board. He confessed that it had been his fate to be a member of the board for many years, during which he was present on occasions of this kind. He did not think that an occasion of a more sad character had come before them than the loss of the wife of their deputy vice-chairman, Mr Riordan. Under any circumstances, it was a painful duty to the members of this board to have to separate on the occasion of the death of any member of the board or his friends, but he (Dr O'Shaughnessy) thought this was a peculiarly sad occasion, because they were separating on account of a man who had filled the chair there with credit to himself and satisfaction to the board; and it was well known in the City of Limerick that the wife of Alderman Riordan was a most excellent woman, a model wife, and a good mother. The Board, therefore, deeply sympathised with Ald Riordan, their deputy vice-chairman, on the occasion, and he had the exceedingly sad duty to perform there—to ask the board to adjourn now.

The proposition was then unanimously agreed to.—Adjourned.
