Refurbish fountain, move Sarsfield and honour John Paul 11 - Cllr Kieran

A COUNCILLOR'S persistent lobbying for a total refurbishment of the water fountain in the historic John's Square has paid off with work recently commenced to restore the decorative fountain that is seen as a centrepiece

Clir Kieran O'Hanlon, who believes that with proper planning John's Square could become very much a focal point, was given a commitment by city manager, Tom Mackey last year that funding would be set aside for the project. That commitment was honoured when an allocation for the work was included in the Estimates for the city in 2007.

Clir O'Hanlon is pleased that the expertise of Limerick Civic Trust, will be available.

"I am, however, requesting that three ugly stone bins that were erected around the fountain be removed. They are incompatible with the historic monument and out of character - they're also a magnet for people dropping bottles, cigarette butts, sweet papers and rubbish," he said.

The councillor, who is also calling for the eventual pedestrianisation of the square, has recommended

Paul lauds praise on staff at oncology unit



that the bronze statue of Patrick Sarsfield, who so gallantly defended Limerick against the Williamite attack inthe siege on the city in 1691, be moved from behind the relative obscurity of a garden area adjoining St John's Cathedral, to a more visible location in John's

Citr O'Hanion said that with the restorative work carried out on the former St John of the Cross Church (now Daghdha Space and the home of the city's professionat dance company, Daghdha and utilised by other performing arts groups) as well as the state-of-the-art restoration of St John's Cathedral, a restoration of the entire square is timely.

"This old area, so close to the walls of Limerick, the

Irish and English towns, and yet leading on up to the newer part of the city, is steeped in history and with a restored fountain, the relocation of Sarsfield's statue, newly laid cobblestones, seating and floodlighting this could become a hugely attractive area for tourists as well as for locals," he said.

"However, we would have to do something about the Wet House and a number off licences nearby. I've always said that the Wet House should have been located on the grounds of St Joseph's Hospital, and now we have the situation where parents have certain concerns about their children going along to the nearby Scout Hall - they've conveyed these concerns to me. This is a pity, as there is a shortage of youth organisations in

the city and we can't afford to lose any".

Another memorial was also on the councillor's mind.

"I will be asking at next Monday's meeting of Limerick City Council, why there is such a long delay in placing a memorial to the late Pope John Paul 11 in the vicinity of the Cathedral, as was agreed by City Council. Another suitable memorial to the late pope was to be erected in the grounds of the former Limerick Racecourse at Greenpark, and there's no progress on this either."

The issues will be raised at the next monthly meeting of Limerick City Council on Monday, Febridary 26.
