

### PUBLIC LIGHTING.

The insufficiency of public lighting in Mulgrave street and Cathedral Place has been commented on by many people who visit the Exhibition. \*After leaving the glare of light inside, the sickly gas light at the corner of Tanyard Lane only serves to make the darkness visible. At all events it is difficult for people to move along on a wet night without running the risk of slipping into a heap of mud or a pool of water. The light from the Exhibition buildings, though powerful, cannot penetrate round a corner nor up to Cathedral Place. The Corporation should supply additional light while the Exhibition lasts.

### THE MONTEAGLE FAMILY.
