FUNERAL OF THE RIGHT HON. M. FINUCANE.

On Tuesday morning, the funeral of the late Right Hon. Michael Finucane, Privy Counsellor and Estate Commissioner, took place from the residence of the deceased gentleman, Monkstown House, Monkstown, to Glasnevin Cemetery. A Requiem Mass for the repose of the soul of the deceased was celebrated in the Parish Church, Monkstown, at nine o'clock, after which the funeral left for Glasnevin. The cortège was of extremely large dimensions, and was of a very representative character. The Vicaroy was specially represented, and the Church, the Bench, and Bar, the medical profession, and the various public departments had numerous prominent representatives. The general public also joined in the last tribute of respect to the memory of a gentleman who was so widely esteemed.

The Requiem Mass was celebrated by the Rev. Louis L. Potter, C.C., and after Mass the Absolution was pronounced by the Rev. Canon Eaton, P.P., and the Rev. Louis Potter, C.C.

SALMON FISHERIES.

Poisoning of Rivers.

At a meeting of the Kenmare Fishery Board of Conservators held at the Courthouse, Kenmare, on Monday, Mr. Henry Percival Maxwell, J.P., in the chair, the following resolution was proposed by Mr. S. O'Brien Corkery, J.P., and seconded by Mr. W. H. Mansfield, and adopted—

"Resolved—That this Board subscribe a sum not exceeding five pounds towards a fund to enable Mr. R. C. Meredith, solicitor, Castleisland, to retain the best leading counsel to seek to uphold an appeal at the Tralee March Assizes, 1911, the decision of his Honor Judge Brown, County Court Judge for Kerry, in which he gave a decree to Mr. Richard Meredith and Mr. Richard C. Meredith for £40 compensation to be paid for the malicious injury in poisoning part of the salmon river Brown Fleck on the 20th or 21st September, 1910, against which decree some of the ratepayers have lodged an appeal, and that copies of the resolution be sent to all the Boards of Conservators in Kerry and Cork, where the nefarious practice of poisoning rivers prevails, and to all the other Boards of Conservators in Ireland."
