## LIMERICK.

George Jefferies, Esq; a young gentleman of great hopes, being of age the 4th inst. the town and castle of Blarney near Cork, were grandly illuminated; and the paper-mills at some distance afforded an additional pleasing appearance; the bells in that city announced the joyful occasion, and the festivity ended without any confusion, though 20 tierces of porter, with other beverage, had been distributed to the populace.

The Sterling, M<sup>c</sup>Clean, from London for this Port, passed by Gravesend the 3d. inst.

On Sunday last, Thomas Gallagher, of the Co. Waterford, in a fit of lunacy, (as we have been informed) took the resolution of murdering his wife, which he enforced by striking her a most violent blow of a hatchet on her head, of which she instantly expired. He was committed to the county gaol, to take his trial at the next assizes.

Extract of a letter from a Gentleman at Killarney to his friend in this City, dated the 28th of January, 1791.

"On the 23d inst. a desperate affray took place between the light infantry company of the 58th regiment of foot quartered here, and some of the butchers and boatmen belonging to this town, the cause of which was as follows:—A butcher having stolen a game-cock from one of the soldiers, was fighting it on the above day, and the owner being present, instantly demanded his cock, on which he was knocked down, and a riot ensued.—Capt. Christmas of the 18th dragoons, and Lieut. Crowgey of the 58th, coming up to make peace, were knocked down, and Capt. Christmas had his scull fractured, and the bridge of his nose broken; Mr. Crowgey received several blows with stones; however, the soldiers were ordered to their rooms, but in some time after the mob pursued, and threw several volleys of stones in at the barrack windows, when the men were at supper, which cut three or four of them in the head in a desperate manner, on which some of the soldiers loaded their pieces with powder, and fired into the street, which further enraged the mob, who by this time procured muskets and fired balls in at the windows, on which the soldiers returned the fire with ball-cartridge, killed two young women, one of whom was servant to Capt. Christmas, and wounded several of the rioters, who have since fled from this town."

Extract of a letter from Dundalk, Jan. 30.

"A most shocking transaction took place on Friday night last at Forkhill, within two miles of this town; at the dead hour of the night the house of the parish school-master was surrounded by a banditti, who, having broke in, took the man, his wife, and their son, a boy of fourteen years old, and cut their tongues out of their heads; after which they took the father and mother and chopped their fingers off. So black and atrocious an act stands unparalleled in the annals of this country; and what
