A pension of £360 a-year falls into the Revenue, by the death of Thomas O'Flaherty, Esq. retired Collector of Excise in this district.

Peter Leahy, aged 18 years, put a period to his existence, at his father's house, in Seward's-lane, John-street, on Sunday last, after returning from chapel. In the absence of his parents at mass, the unfortunate youth placed a ladder over the door, from one of the rungs of which he suspended himself by the neck with a rope, and was found dead on the return of the family. He had attended mass in the morning, and no cause was assigned at the inquest, held by James Bennett, Esq. for the insane act.

By a majority of three, the South Dublin guardians declined investigating the charge of Dr. Mayne's having given Dr. Lees £300 to resign in favour of the former, as Physician to the workhouse. There were seven candidates for the place. Dr. Mayne subsequently denied that he gave Dr. Lees any sum for his resignation.

The Master of the Rolls in Costelloe, minors, has refused the application of Dr. Dillon to have the letting of the house and demesne of Edmondstown, which had been made to Mr. O'Grady, set aside.

At the fair of Rathkeale on Friday, there was a good shew of stock, prices for beef rather dull and few sales. Milch Cows averaged from £6 10s. to £13; fat cows, £7 to £14; Strippers, £5 to £8 In-calf Heifers, £7 to £9; two year old's, £4 10s. to £6; Calves, £2 5s. to £4; Fat Sheep, 28s. to 34s. a piece; Bacon pigs in good demand and rated from 30s. to 33s. a cwt.; store pigs, 18s. to 32s. a piece.

distinguished hero, died on Monday last, at Roscommon." No doubt the above communication reached you in the usual course, but a long and arduous service of several years, as Lieutenant in five of his then Majesty's ships, and subsequently as Commander of the Perseus, forming one of the Mediterranean Fleet under his Lordship's command, enables me to assure you of the incorrectness of the above statement. Lord Nelson's right arm was carried off by a grape shot striking him on the elbow joint as he had just grasped his sword for the purpose of drawing it, when he was about stepping on shore from his barge at the memorable but disastrous attack which was made on the town of Santa Cruz, in the Island of Teneriffe, on the night of the 24th July, 1797, and having been immediately carried off to the Theseus (his flag ship), his arm was amputated above the elbow, by the Surgeon, Mr. Thos. Eshelby, and it was not 'till the 1st of August, in the following year, that we defeated the French fleet, at the mouth of the Nile, where the Admiral was again ('tis true,) severely wounded, but it was in the head, and of such a nature, as to render it very doubtful for some days whether he would survive, and the Surgeon of the Vanguard, (the flag ship at the Nile) was a Mr. Jefferson—in fact I have no recollection whatever of any medical man of the name of "Auchmuty" ever having served with Lord Nelson, or having received a gold medal from him.
