## The KING against CARR.

On Tuesday last, the prisoner George Carr, was brought up to the bar of the Court of King's Bench, when the Judges proceeded to deliver their opinion on the arrest of judgment, pleaded on behalf of the prisoner, Carr, in Michaelmas term last, who was tried in July commission, 1790, before the Hon. Mr. Justice Henn.

The charge was, for forging and uttering a bill of exchange purporting to be drawn by Riggs Faulkner, and directed to John Harman, Jonathan Hoare, and Jerm. Harman, of the city of London, merchants, requiring them to pay to the order of Richard Browne, the sum of 349l. 6s. 8d. at 31 days after sight, and place same to the account of Sir Riggs Faulkner, Bart. Sir James Laurence Carter, Bart. Charles Leslie, and Sir Richard Keblet.

After a final hearing, the Court determined against the points made, and gave judgment, that the prisoner, GEORGE CARR, should be executed according to law.

## A PROCLAMATION.

WESTMORLAND.

WHEREAS the certificate of an indictment found by the Grand Jury of the County of Limerick, at an Assizes held at St. Francis's Abbey, in and for the county of Limerick, the 31st day of July, 1790, before the Honourable William Henn Esq; second Justice, and the Honourable Sir Samuel Bradstreet, Bart. third Justice of his Majesty's court of King's Bench in Ireland, hath been laid before us, by which it appears that William Lane of Manisternena, in the said County of Limerick, Gent. stands indicted for feloniously assaulting and committing a Rape on Lucinda Clanchy, Spinster, of the Age of Thirteen Years, the only Daughter and Heiress of John Clanchy, late of Ballyguiletaghill in the said County, Gent. deceased, on the 31st of Day April last past.

NOW we, the Lord Lieutenant and Council, having a just Abhorrence of such criminal and felonious Proceeding; do, by this our Proclamation, publish and declare, that if any Person or Persons shall, on or before the Tenth Day of March next, apprehend and lodge in any of his Majesty's Gaols in this Kingdom the said William Lane, such Person or Persons shall receive as a Reward the Sum of ONE HUNDRED POUNDS Sterling.

AND we do hereby strictly charge and command all Justices of the Peace, Mayors, Sheriffs, Bailiffs, and other His Majesty's loving Subjects, to be aiding and assisting in apprehending the said William Lane.
