gentleman who travelled in the stage from Enniscorthy to Monastereven last Monday, has favoured us with the following particulars:—A coachman brought a man of the name of O'Connell, on the roof from Kilkenny to Monastereven. On his arrival at the inn, this traveller desired for the nicest things in the larder for a dinner, of which he invited the coachman to partake. While he waited for his dinner he happened to see young Mr. Stoker from Ballyvaughan, whom he offered to treat to a bottle of wine, at the same time pulling out a purse of money to shew that he could well afford to do so.

Stoker having returned to his company, related the circumstance to them, upon which general suspicion arose that he was a robber, which was strengthened by one of the company, who resides in Kilkenny, asserting that a widow Donald had been robbed there the preceding Saturday night, of 302 guineas and some more. There being no magistrate in Monastereven, and the company at a loss to know how to dispose of him, four gentlemen, passengers in the boat from Dublin, were immediately consulted, one of whom happened to be a Mr. Kelly, a very active gentleman, an inhabitant of Kilkenny, then on his return home. It was unanimously agreed that said Kelly should be taken and searched, upon whom were found three half purses, with 100 guineas in one, and 100 in the other, some silver, a dollar, and a pair of silver shoe-buckles. He was then detained in Lord Drogheda's black-hole, the only place of confinement in Monastereven, and the next morning he declared he was sure he would be hanged, as the buckles were the widow's, and she would certainly prove them.—Mr. Kelly carried him back to Kilkenny, where there is no doubt but he will bring him to justice, or to make him turn approver against a set of villains with whom he was connected, who have committed several depredations in and about Kilkenny and Ballyroan for some time past.

Wednesday last, the prisoners brought to the gaol from the New Prison to attend the Quarter Sessions, found means to raise a flag in the boarded enclosure, or crib, as it is called, where they are kept contiguous to the Court, and having practised an aperture, eight of them descended into the Tholsel kitchen, whence running up the stairs, they broke through the crowd in the common hall, and effected their escape.

Tuesday a deputation from the Protestant Members of Dublin waited on his Excellency with a congratulatory Address, in consequence of the happy restoration of his Majesty's health; the deputation was received very graciously, and his Excellency returned them his thanks for their loyalty and public spirit on the occasion. No order or fiat has as yet been transmitted for the Irish Peerage patents; but we are credibly informed, that the *conge d'elire* for filling the vacant See of Cork is on its way. The promotion is pursuant to a recommendation of the Marquis of Buckingham.

We hear, that for want of some necessary documents respecting tithes and other ecclesiastical dues, which long ere this time were expected to have come to hand, Mr. Grattan will defer his tythe bill until the next session of Parliament.

Kilkenny, March 28. On Thursday a remarkable nisi prius cause was heard at the county-court house, before Mr. Justice Duquerry, and a respectable jury, in which the Rev. Mr. Stone, of Kells, in the county Meath, was plaintiff, and Sydenham Davis, Esq; of Johnsville, defendant.—The action was brought to recover 200l. due for tithes leased by the plaintiff, as rector of Kilmocahill, in this county, to the defendant; when, after a trial of some length, the counsel for the defendant produced an unrepealed statute of Charles I. by which it is enacted, that every rector shall reside eighty days in his parish, every year, and preach thirteen sermons, otherwise he will not be entitled to the tithes or dues of his parish; and as it was proved that the rector was non-resident, the jury found a verdict for the defendant with 6l. costs.

Waterford, March 27. On Monday last Walter Butler, Esq; was elected knight of the shire for the county of Kilkenny—on which occasion the city was elegantly illuminated.

Clonmel, March 26. Monday last being appointed to celebrate the heart felt-joy and loyalty of the inhabitants of this town, on the happy restoration of our beloved Sovereign, the morning was ushered in with ringing of bells, which continued with little intermission all day. At night, the town was splendidly illuminated, the inhabitants vying to exceed each other in brilliancy.

Beervhaven, March 21. This morning the Kepple, Hooker, employed in the revenue service by Henry Puxley, Esq; captured a smuggling sloop, the Two Sisters, Shearigg master, off the Great Island of Beervhaven, sixteen days from Guernsey, laden with tobacco and brandy valued at 1200l. sterl. Mr. Puxley's vigilant and successful exertions in that country, have already rendered very essential services to the revenue as well as to the fair trader.

Tralee, March 26. Last week the town of Killarney was illuminated, on the happy restoration of his Majesty's health.

On Monday last, there was an elegant entertainment given at Arbella, the seat of Arthur Blennerhassett, Esq; to a number of the first families in that neighbourhood, on the above happy occasion; and at night the house was beautifully illuminated. In short, nothing was to be seen, for a tract of country of at least nine miles, but bonfires, illuminations, and every other demonstration of joy, which a loyal and grateful people could shew on so happy an occasion.

Last Friday there was a numerous meeting of this County in the County Court House; Crosbie Morgell, Esq; High Sheriff in the Chair, when an Address to his Majesty on the happy recovery of his health—and another Address to the Marquis of Buckingham, were carried unanimously;—after which Sir Vere Hunt, Bart. was voted into the Chair, and the thanks of the County were given to the High Sheriff for his spirited conduct.
