DEATH OF DR J F SHANAHAN.

We regret extremely to record the death of Dr John F. Shanahan, which took place yesterday morning at his residence, Roseville, Limerick, in his 75th year. He had been in failing health for some years, and his demise was not unexpected. Dr. Shanahan, who took out his medical degree in the Royal College of Physicians and Surgeons, Ireland, qualified in 1873, and the earlier portion of his professional career was spent in Adare, of which he was Dispensary Medical Officer for some years. Later on he took up private practice in Limerick, where he also held public appointments—Medical Officer to the Post Office, the Royal Irish Constabulary, and also Dispensary Medical Officer for No. 3 City District. He filled these positions for a long period up to his retirement some years ago, and in the discharge of his professional duties was ever courteous and considerate. He was a member of an old and highly-respected County Limerick family, brother of the late Dean Shanahan, P.P., St Munchin's, and also of the late Right Rev Monsignor Shanahan, P.P., Thuraby-on-Tees, and the Rev Denis R Shanahan, who up to some years ago was Parish Priest of St Mary's. He was brother-in-law of Sir Vincent Nash, D.L., and Mr Ralph Nash, solicitor, County Court Registrar. The news of Dr Shanahan's demise has been heard of with sincere sorrow by a wide circle of friends in city and county, and there is general sympathy with his widow and relatives in their bereavement. The funeral will take place from St Munchin's to-morrow (Sunday), at 1 o'clock, for Mount St Laurence Cemetery.
