typicis all approvation the streets process of taning life, tried recently in Cork, under such appalling circumstances. The menace was intended for a most respeciable employer in this city, as was proved at l'etty Sessions yesterday. The above miscreant was strongly suspected of being accessary to the murder of Daniel Griffin, a country carpenter, at West Watergate, in August, 1840, and, it appeared by the inquiries then instituted, was drinking with Michael Fitzpatrick, also a sawyer, the night and morning of the day on which the latter killed his unoffending victim, by a blow of the stone on the head, for which erime Fitzpatrick was found guilty at Spring Assizes last year, and sentenced to death; but the capital punishment was mitigated to transportation, and the murderer has "left his country, for his country's good."

This morning a poor man name unknown, apparently about 60 years, and wearing an old frieze jacket, a blue plush breeches, grey stockings, but no shoes, was found dead near a lime kiln at Thomond-Gate, by Sub-constable Hardy.
