

ed highly absurd, as his Right Hon. Friend declared himself ready to meet the charge. The question on the Chancellor of the Exchequer's motion was then put and agreed to.

Mr. FREDERICK MONTAGUE rose, and said he should not trouble the House with any debate on this question; but would read a letter which he had just received from Mr. Burke. The heads of this letter were, that the writer of it had no intention of entering on any elaborate, litigious, or artificial defence of his conduct; but had thought a simple explanation, such as he had already given, sufficient; that he had a full confidence in the wisdom and candour of the House, for their determination in this business; that he had, in his capacity of Manager, endeavoured to act to his own honour, and his duty to the House, required; that, as they had entrusted him with so important a charge, they ought to give him credit for an adherence to the dictates of veracity and justice; that, whatever the decision of the House might be, he would not commit himself by entering into a dispute with the avowed agent of the culprit whom he was prosecuting; that, as a Member of a Committee of Secrecy, he would not, by a minute copiousness of detail, in answer to the accusation against him, give the delinquent an opportunity of knowing on what documents he relied for proving what he had advanced in the course of the trial, or what assistance he had received in collecting information that would establish the charges against the prisoner; that he wished to know whether the House intended to remove him from his employment as a Manager; that, if they should, he would patiently submit to their sentence; but, if they should not, he would persevere in his exertions to bring the criminal to justice; that no momentary disfavour from the House should prevail upon him, provided he was not displaced, to abandon the prosecution he had commenced; a prosecution which he had undertaken from the motives of public justice; without being instigated by malice, resentment, or party views.

Mr. MITFORD hoped that Mr. Hastings might not be overborne more by the weight of his accusers than by that of his crimes. He was of opinion, that the Managers were more bound to a scrupulous delicacy and moderation in their harangues, than advocates in an ordinary Court; partly for this reason, that the Lords, from their political connection with the Commons as a House, could not act with so much freedom or superiority towards the Managers as the Judges could towards the Counsel in inferior Courts. He thought the explanation given by Mr. Burke was not satisfactory.

Mr. FOX was willing to admit, that the Managers ought to act as scrupulous advocates, and that they ought not to rouse the passions in opposition to truth or reason. But some distinction ought to be made between a trial for a capital crime, and one for misdemeanours. In the latter case, as there was no certain punishment annexed, it was perfectly fair to collect all the aggravating circumstances that could be stated consistently with truth, as the sentence would vary according to the greater or less degree of the misdemeanor. He then expatiated on the difficulties under which the Managers would labour, if the House, by their conduct on the present occasion, should withdraw their confidence from them. It would be telling them, that those who had bestowed so much time on the impeachment, and were therefore more likely to be masters of the subject than the rest of the House, must be continually liable to be called upon, at the instigation of the culprit himself, to answer for the relevancy or propriety of particular observations or expressions that might be used by them.—This was a bad precedent, and, he believed, was unexampled in the history of impeachments. If the House really disapproved the conduct of one or all of them, the best way

Saturday in the House of Lords, on the second reading of the Jail bill, the Duke of Leinster observed, that the bill was calculated solely for the advantage of a certain Doctor,—who would have himself considered as the HOWARD of Ireland,—had made himself a voluntary inspector of prisons, for which he had already received a salary, but wished it increased by Parliament to 400*l.* a year, for which he proposed an impracticability; that is, the attending at one time the several assizes of the kingdom.—His Lordship moved, “to adjourn the second reading of the bill until the 1st of August,” it passed in the affirmative without a division, and thus the bill was lost.
