Elder, William Scully the Younger, James Hanine, Patrick Hanine, with several others, unlawfully assembled on the Lands of Ballyhoodane, in said County, on the Night of the 2d of March last past, and thereof feloniously drove and carried off six Cows, four Heifers, and nine Sheep, with other Stock, and withheld same on the Hill of Knockroe, in said County, guarded by a Parcel of idle improper Persons in Arms, in open defiance of Law, until the 30th Day of March, ensuing, when then said Stock of Cattle were drove and put into the Pound of Ballymacreefe, in said County, and delivered up to the Pound-Keeper of same.—And whereas on the said Night of the 30th Day of March, said several Persons assembled, and by the Encouragement and Protection of the Pound-Keeper, (as by clear Instances and Proof may appear) feloniously drove and carried said Stock of Cattle out of said Pound, and still feloniously secrets and with-holds same, all which was Sworn by Information before Walter Widenham, Esq; in resentment of which, and in perseverance of said unlawful Felony and Outrage, totally regardless of Law, said several Persons, on the Night of the 20th of April, last, burglariously entered the Dwelling-Houses of my Dairyman, and Herdman, at Ballyhoodane, aforesaid, and thereout feloniously carried Cash and other Matters to a considerable amount.—And said several Persons, on the Night of the said 20th of April, feloniously Stole from off the Lands of Ballyhoodane, aforesaid, one Cow and one Heifer, value 8l. sterl. and not satisfied, or by any means intimidated, but regardless of any Law, headed by three of the Neals, and said Scullys, before Sunrise of the Morning of the 8th of May, armed with Swords, Guns, and other offensive Weapons, entered in and upon the said Lands of Ballyhoodane, and thereof was feloniously driving and taking away ten Sheep and some Lambs, wheteupon four of the Cuninghams who had the care and charge of said Sheep, Stock and Land, on their attempting to with-hold and preserve said Sheep and Lambs for their Master; a quarrel ensued, and thereupon said Cuninghams were so desperately wounded and cut by said Party, with said Swords, Guns, and Weapons, that they ever since languish and were rendered unable to go before a Magistrate to lodge Informations.
