

SAD CITY FATALITY.

Child Rolled Over.

A sad accident, resulting in the death of the little victim, took place in Clare Street on Saturday evening. Some time after two o'clock a boy named Patrick Hayes was on the road when he was rolled over by an empty oil cart, the property of a man named Madden, who did everything possible to avert the accident. The child was taken to the house of his parents at St. Lelia Street, where he succumbed to his injuries yesterday morning.

At noon Mr. J. F. Barry, J.P., City Coroner, and a jury held an inquest on the remains.

Sergeant Soales, Mary street, conducted the investigation, and Mr. P. J. O'Sullivan, solicitor, represented Mr. P. Madden, the driver of the horse and car, which knocked down the deceased boy.

Denis Hayes, father of the deceased, deposed that he lived at No. 6, St. Lelia street. He identified the boy, whose age, he said, was six years.

Stephen Murphy was next examined, and stated that at about two o'clock on Saturday he was driving in Clare street with a load of bags. He saw the child, Hayes, who got on to the end of his car. Witness turned him off, and passed on. He then looked round, and saw the child being rolled over by the wheel of Madden's car. Witness shouted to the driver who did his best to pull up. He got down off the car and brought the child into a house. The cart was at the proper side of the road, and the horse was trotting at the rate of five miles an hour. At the time of the accident Madden's horse was about a hundred yards past witness. There was no other vehicle on the road.

Patrick Madden offered himself for examination, but his evidence was not deemed necessary.

Dr. Roberts attributed death to shock consequent on the injuries received, and the jury returned a verdict accordingly.

LIMERICK TRIENNIAL ELECTIONS.

County and District Council.

The polling for the contested divisions of the Limerick County Council and the several District Councils took place to-day. From particulars to hand, everything appears to be proceeding quietly. For the County Council, ten out of twenty seats are contested, the most notable being in Bruff and Castleconnell where the popular outgoing representatives, Mr. M. P. O'Shaughnessy, and Mr. J. B. Barrington have been called upon to defend their titles. In the District Councils, some interesting contests are being waged. The scrutiny of the votes will not take place until to-morrow. The County Council votes will be counted in the Grand Jury room, County Court-house, and those recorded for District Councillors

At eight o'clock this morning there were fifteen booths in the city for the representatives on the Poor Law Commission. The city returns twenty-four Guardians—three for each ward—or some fourth of the entire body. Polling was slow, but as the day wore on it was noticed in nearly all the wards in the Dock, Glentworth, Cullinstown, Shannon, where lady candidates were in the contest. Up to four o'clock a great number of votes had been recorded, but as a whole, a lack of anything like the excitement played in the contests, which is the personal issue. The number of voters registered is 6,175, composed of 1,468 women voters. At the close of the night the scrutiny of votes will be completed and the results are expected to be known in a few hours later.

MR. JOHN DILLON INJURED.

Excitement was caused in Dunelm when it became known that Mr. John Dillon was lying in the County Infirmary with injuries which he received in a motor accident near the town last evening. It was reported that Mr. Dillon, who was seriously cut and shaken, had been in the infirmary since he was brought there and was progressing satisfactorily. That yesterday Mr. Dillon left the infirmary to attend the celebration at the golden jubilee of the Very Rev. Dr. Quinn, a life-long friend. The motor, that, having reached Swobroke broke down, and another motor was requisitioned to continue the journey. At 3.30 p.m. and 4 o'clock Mr. Dillon was spotted about half-way between Camlough, where the road passes the Slieve Gullion, not far from Forkhill. The road is fairly straight, and the motor was travelling at a rapid pace. A somewhat steep descent carries the road across a stream in Longfield. The gullet forms a narrow channel for ordinary traffic, but to a motor travelling at a rapid pace it is sufficiently steep to cause an awkward jolt. Mr. Dillon, who was unprepared for this, was thrown violently against the glass screen. His head came in contact with the glass, and he was rather badly injured to the head and face. In the rebound he was flung back against the seat, and received injuries to the chest. The chauffeur pulled up at an inn near the spot, and Mr. Dillon appeared to be suffering considerably. He was carried into the house, and Dr. Roberts was summoned. On his arrival Dr. Roberts examined Mr. Dillon's head and face covered by
