By this time a party of the Life Guards, to the number of 30 or to arrived, in confequence of a meffage, fent from the prilon to Mr. Justice Wright; and thorrly after a detachment of the Food Guards, confisting of fifty men, who marched into the rifon, and feveral of the prifoners were fecured.

The diffurbances in the King's Bench Prison have happily subfided. Only two men attempted to escape, one of whom was shot though the hand, and both were retaken from the circumstances of the business, e attempt to escape was evidently an after hought.

The Attorney Gene- yellerday applied to the court of King's pench, and obtained an abtolorise rule for the immediate removal of several of the rioters at the King's Bench Prison, the principals to Newgate, and the abettors to the New Gaol. He stated that the soldiery were yet obliged to keep guard there, night and day.
