

The Committee of the House of Commons have refused the Pipe Water bill, which intended to confer unlimited power on the Corporation of Dublin. Mr. Frederick Jackson, a witness, who has extensive property at Rathmines, said that a supply of good water would be most desirable; but there was no confidence to be placed in the Corporation, who would make a gross job of it.
