

Westminster Hall at a little past one o'clock, when the usual Proclamations having been made, the Lord Chancellor directed the Managers for the Commons to proceed to make good their charges. Major Scott was then called to the Bar, and examined, and in the course of his examination several questions which were put to him by the Managers were objected to by the Counsel for Mr. Hastings, and at last their Lordships were carried back to the House of Lords to give an opinion to a question objected to by Mr. Law, and which had occasioned some warmth of temper on both sides. When their Lordships were seated in the Upper House a short debate arose, in which the Lord Chancellor, Lord Kenyon, Lord Loughborough, Lord Stanhope, and Lord Hopetoun took part, and it was at last agreed, that the Question "ought not to be put."— Their Lordships then went back, and the Lord Chancellor acquainted the Managers with the determination of the House. Major Scott was then called and examined, and after some time another objection arose to the Persian letter of the Munny Begums, and their Lordships again adjourned to the Chamber of Parliament, when Lord Loughborough in a short speech, assigned his reasons for being of opinion why no part of the said Persian letter ought to be admitted as evidence; and upon the question being put, "That the Persian letter produced by Major Scott, as agent for Mr. Hastings, or any part thereof, ought not to be received as evidence against him."

Their Lordships thinking it was then too late to go back and report the answer to the Managers, adjourned till Wednesday next.

Letters Patent have been passed under the Great Seal of this kingdom, for translating the Right Reverend Doctor Euseby Cleaver, Bishop of Cork and Ross, to the United Bishopricks of Leighlin and Ferns, vacant by the death of the Right Reverend Doctor Preston.

Letters Patent have also been passed for promoting the Reverend William Foster, A. M. to the United Bishopricks of Cork and Ross.

Lord Shannon is not only dismissed from the place of Vice Treasurer, but struck out of the Privy Council, and deprived of the government of the county Cork, and all his friends in office share his fate. Two Commissioners of the Revenue are immediately to be turned out.—

These, it is said, are Sir Her. Langrishe and Mr. Bushe, who are to be succeeded by the Hon. Mr. Knox, son of Lord Welles, and Mr. Moore, of Barn, nephew of the Earl of Beville.

Saturday evening, an English messenger arrived at the Castle with dispatches from the Right Hon. William Wyndham Grenville's office, for his Excellency the Marquis of Buckingham, which were immediately dispatched to his Excellency at the Rock.

Dr. Osborne, the family physician of the Marquis of Buckingham, arrived here on Saturday last from Holyhead, and immediately set out for the vice-regal residence at the Rock.

It is reported with the utmost confidence, that the Earl of Carhampton is to be appointed Master General of the Ordnance in this kingdom.

The King of Prussia has just issued an order for a news-paper to be published monthly, and to be distributed GRATIS to the PEASANTS through Silesia, &c. and has further enjoined, that in each district every schoolmaster shall read and explain the contents of the paper to such of his neighbours as cannot read.

DIED. Last Monday, at his seat near Adare, in this county, Wyndham Quin, Esq; the father of the bench of Justices and of the High Sheriffs for said county, which office he served in the year 1747. He was returned to Parliament in August, 1768, for Kilmallock, which he represented for several years. He was possessed of a very social, hospitable disposition, and his death is deservedly regretted by a numerous and respectable family and acquaintance. He is succeeded in his estate by Sir Valentine Richard Quin, an English Baronet, married August 24, 1777 to the Hon. Lady Frances Muriel Strangeways, sister to the Earl of Ilchester.
