

20] This morning, the Right Hon. John Fitzgibbon was sworn into the office of Lord High Chancellor of Ireland, and the seals delivered into his custody.—The oaths were administered in presence of his Excellency the Lord Lieutenant, by the late Commissioners of the Great Seal—the Archbishop of Dublin—Lord Chief Justice Carleton, and Sir Sam Bradstreet.

A congratulatory address from the Irish Bar and Attornies, was this day presented to the Lord Chancellor.

The Duke of Leinster has been dismissed from the place of Master of the Rolls. No successor to him is yet appointed; and it is said to be the intention of Government, when they dispose of it, to retain the patronage in their own hands.

Though the departure of the Marquis of Buckingham for Bath, on account of his ill state of health, is, we hear, determined upon, yet the day is not fixed, no orders for the purpose being as yet issued; his Excellency, notwithstanding his complaint, still, as we are informed, daily attends to the necessary avocations of Government.

The title of Marquis which is said to be conferred on the Earl of Antrim, will in its patent have the same provision contained in the one possessed by his Lordship as Earl of Antrim, whereby the earldom indifferently descends to the male or female heir.

If more than two Marquises are created, and for some days past it has been reported there were to be four, the Earl of Beftive is certainly to be advanced to that dignity. His services to Administration in the Regency business were prompt and persevering; and none more firmly adhered to the Lord Lieutenant through all the changes of that eventful period. These are merits not to be forgotten.

Monday last the Judges met in the Chancery Chamber, and struck the circuits for the ensuing assizes.

Robert Warren, of Jervis-street, Esq; is appointed Chief Examiner of the High Court of Chancery, in the room of Joshua Paul Meredith, Esq; resigned, and William Cruise, of the King's Inn, Gent. is appointed Deputy Chief Examiner of the said Court, in the room of John White, Esq; also resigned.

Trevor Bomford, Esq; is appointed a Six Clerk, in the room of Denis Kelly, Esq.

The Trustees of the Linen Manufacture, at their meeting on the 26th ult. adopted several resolutions tending highly to the interest of the staple manufacture of this kingdom, and among others entered into the following, which we impart with the more pleasure, as it is to be hoped so excellent an idea will lead to similar arrangements at other Boards in Great Britain and Ireland.

Resolved, That if the Chamberlain, or any other Officer attending the Linen-hall, shall demand, take, or accept of any perquisite, gratuity, fee, or reward, from any merchant, draper, or other person attending the said Hall, he shall forfeit his said office, and be rendered incapable of holding any office under this Board, pursuant to the provision made by law for that purpose.

“And if, after public notice be given thereof, any merchant, draper, or other person attending the said Hall, shall give or offer, directly or indirectly, any gratuity, fee, or reward, or make any promise of the same, to the said Chamberlain, or other officer attending the Hall, such merchant, draper, or person, shall never after be allowed any room or standing in the buildings at the said Hall, either by himself, or by any factor or other person.”

Last Saturday the arrival of the news that the Right Hon. John Fitz-Gibbon was appointed Lord High Chancellor of Ireland gave universal pleasure to the inhabitants of this city and county; the bells continued ringing all day, there were many other demonstrations of sincere joy, and at night a general illumination in the City.

The Bank which is to open here next month, will not only be very respectable, but will be of great service to this city and neighbourhood. Punctuality in payments forms the life and sinews of trade, and while the industrious, punctual man will be at all times accommodated with a temporary loan, the rich will learn that men in trade who supply them with many of the necessaries as well as luxuries of life, ought to be paid at stated periods, and not so long forgot as they generally have been in this part of the kingdom.

The Lords Commissioners of the Great Seal have been pleased to appoint Joseph Gubbins, of Maidstown, in the county of Limerick, Esq; a Justice of the Peace for said county.

Mr. Stevelly, of Cork, an eminent Attorney, is appointed one of the Six Clerks in Chancery, in the room of Francis Fetherstone, Esq.

The revenue barge of Waterford spoke the brig Sarah, Capt. Bearthem, of that harbour, bound from Jamaica to Dublin and Lancaster, all well—seven weeks out.

DIED. On the 19th inst. at Park, the seat of Sir Richard de Bourgho, Bart. Nehemiah Donnelan, Esq; aged 82 years, late Lieutenant Colonel of his Majesty's 38th regiment.—He served in the 8th regt. of Foot upwards of 30 years, until he was appointed Lieut. Colonel of the 38th in the year 1759; immediately after which his intellects became deranged, in consequence, as it was supposed, of a very severe wound he had formerly received in the forehead, in an engagement under Prince Charles of Lorraine, which obliged him to quit the service.
