

DUBLIN, JUNE 23.

We hear, that the Lord Chancellor has appointed his nephew, Mr. Beresford, (son to the Bishop of Ossory) to be his Purse-bearer, and Mr. Weekes, an eminent attorney, is appointed Train-bearer to his Lordship.

The Four Courts was more crowded this day, than ever was known on any former occasion, in order to see the Lord Chancellor take his seat in the Court of Chancery,—which he entered at one o'clock; the crowds in the different avenues retarded his lordship's retinue for more than half an hour.

On Sunday an express arrived at the Castle, with an account of the death of Major General James Paterson, Colonel of the 28th Regiment of Foot, and on the staff of this kingdom. The general had set out on a circuit of reviewing, and had arrived at Ballinrobe, in order to review the 8th regiment of Dragoons; but on the morning of the review, just as he was mounting his horse to proceed to the field, he was seized with a fit of apoplexy, and almost instantly expired.

It was to Mr. G. Ponsonby, and not to Mr. M. Beresford, that the Attorney General handed over his briefs, when he received an account of his appointment to the Chancellorship of Ireland.

We hear 'tis out of his Excellency's power to deprive his Grace of Leinster of his Rolls, if he pleases to keep them, as he holds them by patent:—Keep them by all means, honest Leinster, and "don't throw away your bread to dogs."

We hear that the two Hon. Mr. Lyfaghts, brothers of Lord Lisle, have been dismissed from their places of Port Collector, and Collector of Excise of the city and county of Cork; that Colonel Pigot, member for Middleton, has been deprived of the office of Lieutenant-Governor of the city of Cork, and John Townshend, Esq; member for Dingle-couch, and that of Barrack-master of Dublin.

Lord Kingsborough, and Richard Longfield, Esq; are appointed Joint-Governors of the county Cork, in the room of the Earl of Shannon, dismissed.

William Burton, Esq; is not yet returned from his employment of agent to regiments serving abroad—Report says, that Lord Charles Fitz Gerald is to be his successor.

An intelligent Correspondent assures us, that the commencement of the additional tax on newspapers and advertisements in this kingdom, has evidently demonstrates the iniquity of a grievous impost on the public.

Early on Saturday morning, Correlius Jne, cooper, coming from Wandersford, fell into a cellar near the head and nose against one of the steps, as he was passing, and received so violent a contusion on the head, that he died immediately.

Erskine Knight, from the 21st regiment, promoted to the Lieutenant Colonelcy of the 27th, vice Ferguson, deceased.—No other promotion in the 27th regiment has been announced.

The Mary and Peggy, with Rapeseed from this Port, is arrived at Rotterdam, after a passage of six days—as has the Peggy, Durack, with Wheat, at Bordeaux.
