

# ALLEGED SHOOTING IN CLARE

### Magisterial Investigation

At a special court at the Ennis Courthouse before Mr. George M'Elroy, R.M., the three men, Dennis Rynne, Dennis Mescal, and Michael M'Tigue, who are charged with firing at Patrick Hegarty, of Kilnamona, with intent, were brought up on remand in custody.

District Inspector Jackson, Corofin, prosecuted, and Mr. J. B. Lynch, solicitor, appeared for the defence.

The deposition made by Mr. Hegarty was put in by Mr. Jackson. In this Mr. Hegarty said that on June 15 he left home about four o'clock to buy turf some miles away. On his way home, at a place called Rushaun, he saw three men in a field, one of whom raised his aims, and shouted several times. He rode on, but kept looking at the men until they were lost to view. bullet came whizzing between him and the horse's neck, and the horse swerved, and he nearly fell. He clung to the saddle, and the horse galloped on. He heard the report. Then a second bullet passed close in front of him, and he heard the report. A third bullet then passed close to him. When he got to the top of the hill he pulled his horse into a walk. A short distance further on, at the corner of the main road or cross, tw: shots were fired in quick succession, and the bullets passed close to him. In the field, in the direction from which the shots came, he saw four men. Three of them were Mescal, Rynne, and McTigue. It was daylight at the time, and there was no doubt about the men. Witness's sen, Michael, had got a portion of the Shallee farm over which there had been a dispute. Up to that time he had been on good terms with Rynne, but since then he was hostile to witness. On the day of the Ennis races last year Rynne attacked him in Ennis, and said he would blow the orains out of him. The previous day he challenged him to fight and threw a stone at him. Mescal, too, was friendly with him up to the time of the Shallee dispute, and on one occasion swore out that he would do for him. He knew McTigue, but had not seen him for some time.

Acting-sergeaut Counell, Inagh, gave evidence of the arrest of the defendants on the charge of firing at Pat Hegarty with intent to murder. He had not completed his arrangements, and asked for a remand for eight days.

By Mr. Lynch—He had heard Mr. Hegarty swear that he identified the defendants.

Mr. Lynch said he did not see the object of the remand. Mr. Hegarty's deposition clearly identified the defendants. It was a serious charge, and they were entitled to be tried at the first tribunal, the next Assizes for the county, which would be held on Saturday. Otherwise they could not be tried until the Winter Assizes, and that was too long to have such a charge hanging over them.

Mr. Jackson pressed for the remand.

Mr. M'Elroy said he should take into consideration what he knew judicially about the matter. Over this unfortunate Shallee farm the whole district was in a very disturbed state, ever since this time last year, when the farm was divided. He was responsible for the peace of the district, and he should do everything he could to nut a stop to this disturbance.
