All the assistance possible was given by Messrs Walshe, Millar, and Murphy; while Mrs Millar and Mrs Walsh rendered succour to Miss Couninan. They looked after her in every way possible and accompanied her in the Corporation ambulance to the Hospital.

THE CITY CORONERSHIP.

Resignation of Mr J F Barry

Mr James F Barry, who has occupied the position of City Coroner, has sent in his resignation of the office to the Corporation. Mr. Barry held the position since 1911, when he was appointed on the death of Mr. Matthew DeCourcey, and during that period he discharged the Carles often trying and arduous, in a manner creditable to himself and to the satisfaction of the citizens. In his letter of resignation addressed to the Mayor under date the 28th Juna, Mr Barry writes :- " I beg to tender my resignation of the office of Coroner for the City of Limerick, having relinquished my Commission of the Peace as a preliminary step. I take this opportunity of thanking the members of the Council for their unfailing courtesy and kindness to me on all occasions in my discharge of the duties of Coroner. As you have doubtless seen in the Press my authority as Ocroner has been questioned in the House of Common, and I am no longer in a position to enforce my decrees, even to a jury. Taking this and other matters into conaideration, I am convinced that resignation of the ancient office of Coroner is the only honourable course open to me, and I now respectfully sak you to accept same. On the occasion of my appointment I promised the citizens of Limerick that I would endeavour to uphold the dignity of the oou t over which they elected me to preside for the time being, and without egotism I presume to say that I have carried out that trust faithfully.

The letter will come before the Corporation at

its meeting to night for consideration.

CROOM DISTRICT COUNCIL.

At the fortnightly meeting of the Croom District Council, held on Thursday, 24th June, Bhaun Useal O'Clomain in the chair, the following resolution was proposed by Mr William Haffernan, seconded by Mr John D O Dwyer, and passed unanimously:—"That pending a satisfactory settlement of the sale of unpurchased lands of Ireland we, the Croom District Council, wish to draw the attention of the public to the fact which cannot be disputed that unpurchased tenants are more unfavourably situated than their neighbours who have purchased, often to the extent of £40 on every £100 rent. That such being so, unpurchased tenants cannot be expected to meet all the demands made on them in the labour market, and for all the necessaries of life, which demands have to be satisfied equally with those made on uppurchased tenants.

"Therefore, be it resolved that in future all unpurchased tenants demand a reduction on existing rents which will be the equivalent of the reduc tion now enjoyed by their more fortunate pur-chased neighbours. That copy of this resolution be sent to the Press, the County Councils, and Rural District Councils in Ireland."

Arising out of complaints made that pumps in the Rural District were often damaged by loom parties, on the motion of Mr Lysaght it was unanimously agreed that the Council would issue s caution to parties demaging pumps, that if found wantonly destroying property, they will be summoned before the Sinn Fein Parish Courts and severely dealt with.

LIMERICK ASSIZES.

At 11 o'clock on Wednesday next the Limerick Summer Assizes will be opened by the Hon Mr Justice Moore and the Hon Mr Justice Samuels. The former will preside in the City Court and the latter in the County. There are in all four oriminal cases for hearing, two from the city and two fr. m the county, and these consist of one charge of housebreaking, one of larceny, a third of assault. and a fourth of false pretences. There are fifty-nine appeals fifteen being for malicious injury, and a few records.

DEATH OF MR JAMES O'DONOVAN

Sincere regret will be felt at the demise of Mr James O'Donovan, Athluskard-street, which occurred yesterday evening at Barrington's Hospital. He was a member of an old and respeoted city family, who have been always engaged in the pig-buying business, in which the deceased was also occupied. He had not been in the best of health for some time past, but it never occurred to his friends that his condition was such as to cause any encasiness, and hence the news of his death came as a great shock to the many citizens by whom Mr O'Donovan (or Graily, as he was by whom he hown), was highly esteemed.
