### THE SILVERMINES TRIAL.

#### Jury Unable to Agree

At the Four Courts, Dublin, yesterday, before the Lord Chief Justice and a special Co. Dublin jury, the hearing was continued of the case in which two brothers—John and William O'Brien—are charged with the wilful murder of an old man named George Sheehan at Silvermines, Co Tipperary, in January, 1918.  
The jury were unable to agree, and on the application of the Solicitor-General, his Lordship made an order remanding the prisoners to Mountjoy Prison.

### APLOTMENT TENURE.

At the meeting of the Corporation Committee last night, the Mayor presiding, a resolution was unanimously adopted asking the Department of Agriculture and the Local Government Board for information as to the future conditions regulating applotment tenure, and requesting the Borough Council to arrange for obtaining information as to the position of the tenants. The scheme for the letting of applotments expires this year, on the conclusion of peace, and the tenants are, in the circumstance, desirous of ascertaining what the Department and the Local Government Board propose with regard to the lettings.

### THE SHANNON TRAGEDY

The funeral of the late Mr William Griffin, North Strand, one of the two victims of the tragic boating accident near Cain's Island on Sunday evening, took place yesterday from St. Manohin's Parochial Church for Mount St Lawrence Cemetery, and the large cortege present testified to the deep respect in which deceased was held and of the sadness caused in the city by the fatality. The St. John's Temperance Brass and Reed Band, of which deceased was a member, played the Dead March.
