The General Affembly of Philadelphia have passed a bill for the establishment of a militia; by which it is to be divided into two diffinct bodies, a general and distinct militia. The general militia is to confit of all between eighteen and filty-three years of age; they are to turn out one day in every year, and pay a certain finall fum each to the support of the corps .-The felect militia is to confilt of a legion, containing 2048 rank and file. This corps is to be composed of volunteers, if such should offer: if not, the deficiencies to be made up from the general militia by lot. This corps is intended as a military school, from which the State is to be furnished with a good militia, and always will thus be prepared for defence. The Revenue in France will, for the present
