they shall detect offending against the Fishery
Laws; and as the fishing season has expired the
1st inst. hope that no gentleman or others will
be so inconsiderate as to Angle for, or otherwise
attempt to take red Salmon, red Pale, Salmon
Slats, or spene Salmon, or spent Trout or Dul-
aghans, or by any other name by which such fish
are usually denominated, on any part of the river
Shannon, or that great Nursery of it, the river
Muircare; and that any person, until the 1st of
February next, having such fish in their possession
or exposing them to sale, shall forfeit a sum of
5s. for every such fish found in his, her, or their
possession, the same to be levied by distress and
sale of the offenders goods, and if such sum
cannot be levied, then such offender shall by a
Justice of Peace be committed to the County gaol
or House of Correction, for a space not exceeding
one month nor less than fourteen days for
the first offence, and not exceeding six months
nor less than three months for every future of-
fence.—Justices refusing or neglecting to act,
shall for every neglect or refusal, forfeit the pen-
alty of 20l. to be recovered by Civil Bill before
any going Judge of Assize, in the county where
such Offences shall be committed.
