and fatal. He concluded a speech of some length, and replete with much sound argument, by submitting to their Lordships, that there were obvious and sufficient errors on the face of the record to arrest the judgment.

He was followed by Mr Arthur Browne, who stated that the issue in this case was joined on the 13th of June, and that the test of the writ of Venire was dated the 12th of June; this, he said, was, in the first instance, a fatal objection; the Venire, he said, could not have been awarded till the issue had been joined, and the writ is antecedent to the joining of the issue, whereas it should have been subsequent. The trial, therefore, was a mis-trial, the Jury not being duly authorized to try. The second objection was, the award of the writ of Venire says to come on on Tuesday next, after three weeks from the Holy Trinity. The test of the writ is the 12th of June, and the feast of the Holy Trinity was on the 7th, which was five days previous to the issuing the writ. Mr. Browne made many other strong objections, and in support of his arguments, cited a great number of cases, and dwelt on each for some time, and deduced inferences from them favourable to his client.

Mr. Hacker, on the same side, said, that with the indulgence of the Court, he should reserve himself for a reply to whatever arguments might be offered on the part of the prosecution.

Mr. Calbeck, for the prosecution, answered the objections made by Mr. Sheridan; he said they were frivolous and futile, and such as could be by no means supported.

Mr. Walker, on behalf of Mr. Magee, in a speech of some length and uncommon animation, insisted that there were errors on the face of the record sufficiently strong for arresting the judgment.

It being then a quarter past three o'clock, the hearing of further arguments in this very interesting cause, was adjourned to 11 o'clock on Friday.

Friday the pleadings in the above cause were continued. Counsellor Keller argued in behalf of the arrest, and was replied to in a speech replete with eloquence and argument by Counsellor Curran. The pleadings having lasted until near three o'clock in the afternoon, the Court adjourned the business until Thursday.

Thursday Mr. Magee was brought up to the Court of King's Bench, when he was admitted to bail in his own recognizance, until the opinion of the Judges should be known.

Notwithstanding the machinations and invidious reports circulated to prejudice the minds of the public, by the enemies of Mr. Magee, he on Thursday last gained a complete victory over the *Sham*, by the discovery of some errors in the record, by which judgment could not be passed upon him, and of course that business has fallen to the ground.

Yesterday during the proceedings against Mr. Magee in the Court of King's Bench; some practices were discovered which must cast an indelible stigma on the persons concerned; it is no less than altering the dates of the Records of the Court, respecting a late Trial; when a certain Counsellor was examined touching this ugly affair—he seemed to prevaricate very much—and from the complexion of the business it is strongly suspected that the parties concerned are in a perilous situation.

When Mr. Magee was discharged out of Court, as soon as he got into High-street, he was taken into custody by the Sheriffs on different Fiats.
