salted a parcel post-post class, and cream and honey, gives an increase for this year's show of 28 entries, the numbers for 1899 being 347, and for 1900, 375. Entries of honey have considerably decreased. The parcel post class keeps up its numbers creditably, 21 entries being received here for butter most suitable for the parcels post, the postage of the butter, including the package, not to exceed nine pence.

Farm produce exhibits this year give a big increase over those of 1899, amounting to 154 entries. Last year's were 489, while this year's amount to 643. Malting barley grown in Ireland has 229 entries, the first prize in this section being £15. The sum of £230, presented by the Barley Committee to provide for special prizes, will be allocated according to the following scheme:—For barley grown in the Counties of Dublin and Wicklow, Meath and Westmeath, £20; Louth, £20; Kildare, £20; Carlow, £10; Wexford, £30; Kilkenny, £20; Queen's, £30; King's, £20; Tipperary and Waterford, £30; Cork, £20; and all others, £10.

The poultry classes are particularly numerous, entries this year showing an increase of 134 over those of last year. In 1899 the numbers were 510, and this year they are 644. All the various breeds are represented. Dead poultry entries are 34 against 28 last year.

There will be a show of implements, machinery, &c., in the grounds, and stock will be received at the Society's premises, Ball's Bridge, on Monday, the day before the opening of the Show, but none will be admitted after that day.

BURNING ACCIDENTS IN THE CITY.

FATAL RESULT.

Quite a number of burning accidents have occurred in the city within the past two days—in one case with fatal results, and a second is also likely to terminate fatally. Timothy Ryan, seven years, was admitted to Barrington's Hospital on Tuesday suffering from burns caused by falling into the fire during the temporary absence of his mother from the house. The boy succumbed to his injuries yesterday morning, and the facts were communicated to the Coroner, who did not consider an inquest necessary. Patrick Waldron was treated in the hospital yesterday for burns sustained by coming into contact with the fire, and his parents, were slightly burned in their efforts to rescue him. Anastatia Elligott, Town Lane, was treated in the same institution for burns received in a similar manner. The child was removed to St. John's Hospital, there being no accommodation in Barrington's. Michael Gorman, aged 7, living in Carey's Road, was admitted to Barrington's Hospital yesterday, suffering from burns. His case is regarded as serious, and his recovery is not expected.

ATTEMPTED SUICIDE.

Stephen McCarthy, aged 23, labourer, living in Dillon's-lane, Irishtown, was observed to throw himself into the river from the bridge near Barrington's Bank yesterday evening. A soldier named Coleman, who witnessed the occurrence, shouted at the apparently drowning man, and with the assistance of a comrade named Carroll succeeded in rescuing him, and he was subsequently taken into custody by Acting-Sergeant Power, Mary-street. Statements made by the poor fellow showed that he was suffering from religious mania. This morning he was brought before Mr. Guinane and Mr. Clune, J.P.'s, who gave an order for his committal to the asylum.
