re-committed for re-transmission to Spike Island, a ticket of leave convict named Murphy, for stealing a pair of trousers belonging to a sailor on board one of the vessels in the river. George Sergeant, one of the day police, charged an old woman with stealing a pair of ducks which she insisted were her own property and Sergeant's evidence being *paradoxical* (?) the old woman was discharged.

In the case of the Earl of Kenmare against Cornelius Casey for taking forcible possession of the lands of Kilbohane, and which came before the bench, at Killarney petty sessions, on summons it appeared that the original was not stamped at the time the duplicate was served, but had the stamp subsequently affixed, the court held that as the 21st section of the 21 and 22 Vic. chap. 100, provides "that every document enumerated in the schedule C., shall, after the 1st day of January, 1859, be printed or written upon paper, bearing a stamp denoting the amount or value set opposite to such document in that schedule," and Mr. Levinge in his work, page 313, says, "that the magistrate when called on to sign a summons should first see that the summons is stamped," because it would tend to a fraud on the revenue, and would be opposed to the law if any person, no matter how respectable he may be, should be at liberty to fix the stamp after the summons was served." The case was adjourned to have the Castle law advisers' opinion on Levinge's law.

THE LATE ADJUTANT GRANT.—Upon the occasion of the death of this lamented officer the following order was issued on the 10th inst., by Colonel A. Borton, C.B. Commanding 17th Depot Battalion in this garrison:—"It is with much regret that the Commanding officer announces to the Battalion the loss it has sustained by the death of Captain and Adjutant Grant, an old and much-esteemed officer who, by his exertions during the past few years, has much contributed to its efficiency." The officers are requested to show their respect for his memory by wearing crape with their uniform above the left elbow." Captain Grant served with the 2nd Foot during the campaign of 1844 and '45, in the Southern Coucan and Sawant Warree country, including the storming of several stockades, and the investment and capture of the forts of Monohur and Muastosh.

Lieutenant William Benn, Donegal Artillery, has joined his Regiment at Letterkenny, from Barna, Newport, Tipperary, for the usual annual period of training.

On Sunday last, during the afternoon, a party of men belonging to the King's Co. Militia, now embodied, entered a public house in Townsend-street Parsonstown, the party consisted of a sergeant, a corporal, and a few privates, who, whilst partaking of some drink, got into an altercation, which resulted in blows being exchanged, and an affray also took place in the streets; the combatants were parted by the constabulary and bystanders. Since then the sergeant and corporal engaged have been tried by a Regimental Court-martial, and were reduced to the ranks. The former is also ordered to be confined to barracks during the embodiment.
