JUMPING OVER THE NIAGARA FALLS.

SUICIDE OF A LADY.

News from America states that on the 5 h inst. an unknown woman jumped into the Niagara River and passed over the Falls shortly before noon. The woman, who was dressed neatly in dark clothes, was of light complexion and apparently about 25 years of age, was seen walking carelessly toward the Niagara River, a short distance above Prospect Point. Soon after reaching the river she was seen by visitors near the Falls to toss her hat and parasol lightly into the river. A moment afterwards she glanced hurriedly around and then deliberately leaped into the Niagara Rapids. The waters caught her up like a straw and bore her rapidly towards the American falls, head first, her arms swinging in the air. As she approached the brink of the falls her face was turned for a moment towards Prospect Point, not twenty feet away, when a number of horrified, spectators stood spelebound unable to render the slightest assistance had they so desired. She was evidently up to this time in full possession of her mind, and uninjured. Just as she was passing over the brink of the falls one arm was raised apparently in an endeavour to make a motion. Aer eyes were wide open, the face wore a calm expression, and a smile on her lips was quite discernible. One moment of awful suspense and the body was borne from view by the rushing cataract.
The captain of the Maid of the Mist shortly after-

wards saw the body floating in still water between the American falls and the Canadian free park, but before his boat could reach it the body disappeared from sight. The deceased was reported to have been stopping at Spencer House, where, it is claimed, she registered her name as Mrs Lawrence, of Brooklyn, NY. There seems to be a lack of evidence required to make a substantial connection between the lady registered as Mrs Lawrence and the suicide. The body had not again been seen, and no new facts were elicited that would tend to throw any light

a DREADFUL SUFFERINGS AT SEA.

Plymouth, Monday. The Pacific Company's steamer Ornba, which arrived here to-day from Valparaise, brought among her passengers nine of the survivors of among her passengers nine of the survivors of the bark Georgina, of Swansea (Captain Watkins) which was we cked on August 21st on the English sandbank near Monte Videe, She was from New-pirt with coals for Rosario, and in hazy weather ran on the bank under a press of sail at half past crew-fifteen all told-were not rescued until noon on the following Saturday. For the first 24 hours after sounding, the wreck was being continuously washed over by seas. The crew had then to take refuge in the rigging, where they were further expised for 44 hours without food or water. From the mizen top they had to climb to maintop and ultimately to the foretop. Monday an apprentice boy was so prostrated that in climbing from the mizen to the maintop he lost his hold, fell overboard, and was drowned. Great feeling was exhibited where the wrock was early known at the men net being rescued for so long. A tug went out several times, but returned without at empting to give any aid. Ultimately 10,000 dellars were raised and offered as a reward for the rescue, which was accoplished on Saturday by a tug and two life boats. The shipwrecked seamen, on landing, were taken every care of and supplied with food and clothing and £50 in money which was divided between them.

was brought to a sudden termination. party was suddenly disturbed by the entry of Inspector Mitchell and Mr Fred Woodall, son of the head of the London firm, who had most cleverly tracked Mr Miles all the way from England. Woodall, proceeded in the Etruria to Liverpool, en route to London.

THE IRISH MILITIA.

The general annual return of the British Army for 1888, issued from the War Office, shows that last year the number of the Irish Militia who were present at training was 22,360; absent with leave, 1,045; without leave, 1,683; making a total enrolled strength of 25,088, out of a total establishment of 31,222, leaving 6,134 wanting to complete the establishment. The number enrolled on 1st January, 1888, exclusive of the permanent staff, 22,034; the number who enlisted in the year was 4.305; r--enlisted, 480; r-joined from desertion, 148, but against these are to be set 76 dead, 1,987 discharged, 1,610 deserters and absentees struck off, 1,346 who joined the regular army, and 20 others, making a net decrease in the enrolment on the 1st January, 1889, of 106, the actual number then encolled being 31,928. The militia reserve of Irish regiments shows a small increase during the year of from 7,324 to 7,351.
